Hotel

A block of rooms has been reserved at The Tuscan Hotel at Fisherman's Wharf, 495 Jefferson Street, www.tuscanhotel.com. Rooms are available for Wednesday, April 26 and Thursday, April 27. The rate is \$189 per night, single or double. Note that this is within the judicial branch reimbursement rate. Parking is available at \$55 per night with in and out privileges.

To make reservations, you must contact the hotel directly. Please call the group reservations line at 415-292-4535 and ask for the JEM Forum block. The hotel deadline is March 22, 2017.

Employees of California courts must present the completed Transient Occupancy Tax Waiver Form, which can be found at https://www.documents.dgs.ca.gov/dgs/fmc/pdf/std236.pdf, and show your Court-issued identification at check-in.

Airport

San Francisco International Airport

The most cost-efficient way to get to the hotel from San Francisco International Airport is to use Super Shuttle. Make reservations in advance at www.supershuttle.com. The cost is \$17. The trip takes about an hour, depending on traffic and the number of stops. Follow the signs on the departures level for "shared van service."

A cab ride will cost about \$60 and take about an hour. Uber and Lyft serve SFO.

Oakland International Airport

BART is the only option from the Oakland International Airport. Follow the signs for BART in the terminal. Take the 8-minute tram to the Coliseum Station and board a San Francisco/Daly City bound BART train to the Embarcadero Station. The trip takes about 50 minutes and costs \$10.20. Purchase your ticket from the vending machine at the Coliseum Station. From Embarcadero Station, hail a cab to the hotel; the journey will take 10—15 minutes and cost approximately \$20.

Amtrak

Amtrak service terminates in Emeryville. From there, the Thruway Bus takes you to Pier 39 in approximately 55 minutes. From Pier 39, walk down Beach Street to Leavenworth Street, turn right for 1 block, turn left on Beach Street. The hotel is in the middle of the block on the left. The total walk is 8 blocks. From the Hotel to the Judicial Council Conference Center

(The same directions work for the Courthouse, which is across the street from the Judicial Council Conference Center)

<u>Cab</u>

A cab ride will take 15 - 20 minutes and around \$20.

MUNI Bus

The #47 MUNI bus stops directly across the street from the hotel. A one-way trip is \$2.25 and takes about 30 minutes. Exact change is required. Enter via the front door and use the fare box; be sure to get a transfer/proof of payment from the driver. Get off the bus at Van Ness and McAllister Streets. Cross Van Ness Avenue and walk down McAllister Street for one and one-half blocks. After you cross Polk Street/Dr. Carlton B. Goodlett Place, the Judicial Council building is on the left. (Note that although the Judicial Council building's address is Golden Gate Avenue, it also has an entrance on McAllister Street.)

<u>Uber or Lyft</u>

It is about a 10 – 15 minute ride to the Judicial Council Conference Center.

Parking for the Judicial Council Conference Center and Courthouse

Use the Civic Center Garage, McAllister Street between Polk/Dr. Carlton B. Goodlett Place and Larkin. The garage is underneath the Civic Center Plaza and across the street from the Conference Center. Rates range from \$1 to \$5.50 per hour, based on time of day and demand.

From the Judicial Council Conference Center to Either Airport

BART

The Civic Center BART station is 2 blocks away. BART to SFO takes 30 minutes and costs \$8.95. BART to Oakland International takes 40 minutes and costs \$10.20. Purchase tickets from the vending machine in the Civic Center BART station.

From the Judicial Council Conference Center to Amtrak

Cab

Take a cab to the Ferry Building. The journey takes about 20 minutes and costs about \$20. Board the Thruway Bus to Emeryville. The journey takes about 50 minutes. Board the train in Emeryville.
