1	Kathleen Shambaugh	Contra Costa: No lunches during deliberations. I can't remember a time when we had a jury sequestered to answer the 2nd part of your question.
2	Diana Gifford-Tuggle	Shasta County does not provide any food for deliberating jurors. We do provide coffee, tea and water. Some of the judges do provide donuts if it has been a long trial. To date, we have not sequestered a juror panel.
3	Lupe Castaneda	Santa Clara County the judges provide snacks during deliberation but not lunch
4	Deborah Preston	Marin, there is no free lunch, even if you are a deliberating juror. We have not sequestered in my memory.
5	Debbie Jurevich	San Benito does not provide lunches. We have not had a sequestered jury since I have been with the court. We do have one Judge that prefers we make coffee for the jurors and often times I will provide a small basket of candy for the jurors when on break.
6	Therese Phelps	Plumas does not provide lunch for jurors. We have not had a sequestered jury in the past ten years.
7	Rose Hamblin	Kings County is the same as Shasta County including some of the judges provide donuts
8	Diane Collins	Mendocino County does not provide jurors lunch. In fact, I have to "pull teeth" to get Admin to provide bottled water during deliberations. In fifteen years we have not had a sequestered jury
9	Edwina Harper	Yolo County is the same as Shasta County.
10	Julie Griffith	Kern does not provide lunch. We have had a sequestered jury to my knowledge in the past 30 years
11	Arlene Cervantes	Riverside we would provide dinner for jurors who are deliberating past 5:00 p.m. and lunch for sequestered jurors. Very rarely does this happen.
12	Sherry Spears	Fresno does not provide lunches to deliberating jurors with one exception. We did provide lunch to jurors during deliberations in a high profile trial in 2005 and had a limit for the cost of the lunch and it needed to be in a semi-private area. I had the job of finding restaurants with semi-private areas or rooms or caterers that could bring lunch in for about a 2-week period. But that was out of the ordinary and only because the trial judge was very concerned about the publicity level in the death penalty trial.
13	Sabra Forbes	Yes. Solano County provides lunch to jurors during deliberation only
14	Tammy Boragine	Amador, no free lunches for jurors, deliberating or not, in Amador County. We have not had to sequester yet. There have been occasions where the Judge will buy snacks (donuts or cookies) and lunch for deliberating jurors. We do provide coffee. – Tammy
15	Dolores Curiel	Merced, we do provide lunches to jurors, upon a request from the Judge. Dinner is sometimes provided to jurors if they are in deliberation into the evening
16	Lynda Pierini	Madera does not provide lunches
